## 2022 GENERAL WELFARE ASSISTANCE ELECTION

Funds contributed to your General Welfare Assistance Account may be used to pay for eligible expenses under the following types of benefit categories including Health, Utility, Education, Nutrition, Housing, Childcare, Cultural, and Transportation. Benefits may be accessed using the FSA TPA Debit Card, Nutrition Benefit Card, direct provider payment(s) or by a manual claim for reimbursement. Any unused benefits will roll forward from month-to-month through the duration of the plan year.

With your election, you hereby certify your participation in the SBLI General Welfare Assistance Program for the 2022 Plan Year. The monthly GWA benefit will be deducted from your monthly per-capita distribution up to a maximum of \$6,000. Your GWA benefit election will be irrevocable and remain in force for the remainder of the Plan Year ending 12/31/2022.

<b>NEW FOR 2022: TRANSPORTATION STIPEND (Optional)</b> <b>ENTER YOUR MONTHLY TRANSPORTATION ELECTION:</b> Maximum contribution \$2,000/month. Amount to be <u>deducted</u> from monthly GWE contribution. <small>As a reminder, all transportation stipends are processed on the first business day of the month. Participants receiving their stipend as direct deposit should see the deposit post to their designated bank account within 48 business hours of processing. All direct deposits will appear from MBI Bank or MBI Settlement Bank.</small>	\$
<b>NEW FOR 2022: FOOD CARD (Optional)</b> <b>ENTER YOUR MONTHLY FOOD CARD ELECTION:</b> Maximum contribution \$1,000/month. Amount to be <u>deducted</u> from monthly GWE contribution. Will be administered via a separate food card.	\$
<b>OTHER GWA ASSISTANCE:</b> <b>ENTER YOUR MONTHLY OTHER ELECTION:</b> Funds can be used to pay for other eligible GWA expenses such as Health, Housing, Utility, Education, Childcare and Cultural.	\$
<b>ENTER YOUR TOTAL MONTHLY GWA ELECTION:</b> Maximum contribution \$6,000/month. Please note the maximum allowed monthly contribution into the GWA Program is \$6,000.00 across all Programs (transportation, nutrition and other GWA combined).	\$
