Purpose

he Soboba Foundation is a nonprofit corporation organized exclusively for charitable and educational purposes, as contemplated within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law) ("Code"), including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code.

The Soboba Foundation strives to serve in a most valuable way, and we welcome your input and involvement to help ensure the continued success of our important work. Our combined experience from the past can be utilized in the present to help build a brighter future. 2024 here we come!

welcome this opportunity to share with you the diversity of sponsorships that are awarded according to our guidelines for giving. Overall, we were fortunate to be able to provide almost half a million dollars to deserving nonprofits, groups, individuals and sports and youth organizations to continue their valuable work in their communities. More than half of that money provides support for other Tribes' endeavors as well as requests from our own Tribal members that are part of many



local organizations. We were able to provide higher education scholarships to local high school seniors totaling \$17,500. The Foundation funded additional educational activities in the amount of \$33,480. Through our local school districts, we sponsored Turkey Meal distributions for \$200,000 and purchased \$125,000 worth of toys and gift cards to serve children in the community. After reviewing the financials, we as a group know that next year we need to increase admission costs for the Lip Sync Contest, one of our most well-attended events that supports about a dozen nonprofits. The 2022 990 tax return has been filed and can be found on the IRS's website. We understand the need to give will be greater in 2024 due to the economy, but please know that we are working hard to find a balance to continue to support those in need. We are planning to stay the course and reduce the amount we give to some entities in order to assist the increased number of requests we will undoubtedly receive.



Our History

he vision of the Soboba Foundation can be seen through its mission statement, which is to provide financial assistance for educational and charitable activities that preserve the cultural heritage of the Soboba Band of Luiseño Indians and support Native American and local community programs. By striving to achieve this mission statement and overall vision of the Tribe, the Foundation is able to provide much-needed assistance and funding to organizations and charities that are in need of support. Since its establishment in 2010, the Soboba Foundation has been successful in achieving its mission and will continue to strive to continuously meet this goal year after year to ensure that this type of support is continued.

In its efforts to achieve the visions of the Soboba Band of Luiseño Indians, the Foundation continues to offer financial assistance to Tribal organizations, nonprofit charities and other community organizations within Southern California. Specifically, the Foundation aims to support educational, health, economic development, and special projects within Southern California.

The Soboba Band of Luiseño Indians allocates funding to the Soboba Foundation for charitable giving purposes that are distributed to various organizations or



nonprofit groups. Organizations may apply for funding by way of an application submitted for funding consideration. These applications are reviewed by the Soboba Foundation Board of Directors. During their regularly scheduled meetings, the Foundation Board determines whether the request for funding falls within the funding priorities of the Foundation.

The efforts to achieve the mission and vision of the Soboba Foundation is driven by the commitment and dedication of the Soboba Foundation Board of Directors and staff.

Although elections for new Board Members are held every two years, each new Board continues to move the Foundation forward while always keeping the mission and vision in mind.



2023 Highlights

he Soboba Foundation granted 110 requests for sponsorships to a wide variety of nonprofit organizations, several Tribes, sports programs that serve youth in the community and for educational programs and needs. Many special event fundraisers to help nonprofits meet their demands for the vear were funded by the Foundation. These events are also important to unite the community and perpetuate interest in causes for future generations to get involved.

The Foundation's funding priorities are directed to organizations that provide educational, health, economic development or special project services in San Bernardino and Riverside counties and to Tribal Governments and Tribal nonprofit organizations

throughout the United States. Community-wide events that contribute to its economic development are most welcomed.







Special projects and programs that involve youth are also given priority.

Those who benefited from sponsorships in the amount of \$10,000 or more this year included The Friends of Valley-Wide Foundation for its annual "The Weekend" and "Autumn Elegance" fundraisers, several local Tribes for their annual golf tournament fundraisers, American Cancer Society for its Relay for Life and Survivor & Caregiver Luncheon and the Hemet-San Jacinto Valley Chamber of Commerce for several community events that help local businesses network.

The Foundation is looking forward to continuing its support of deserving programs, causes and individuals seeking higher education assistance. The

goal is to help as many organizations as possible contribute to a healthier, safer and happier community through the many charitable activities they offer.



Since the first one in 2013, the San Jacinto Fun Run has continued to be a fun, family-friendly community

event, welcoming runners and walkers of all ages. All proceeds from the 2023 race were given to the San Jacinto Education
Foundation, a nonprofit that is dedicated to providing resources, opportunities, grants, scholarships and recognition to the students

Soboba Gives Back to Brighten the Holidays for Local Families

ach year, the Soboba Foundation, in partnership with the Soboba Band of Luiseño Indians and the Soboba Casino Resort, offers families with children attending local schools the opportunity to enjoy a complete turkey meal for Thanksgiving and toys for

Christmas. In 2023. the Hemet and San Jacinto unified school districts identified those families that would go without if not for the generosity and compassion they receive from Soboba, Each district received









1,000 frozen Butterball 20-pound turkeys and all the fixings to go along with it to distribute during drive-through giveaway events that attracted hundreds of volunteers from the community. In December, each district received 1,000 toys during the popular Unstuff the Bus events where all ages pitch it to transport toys from the Soboba bus to a safe storage area. The toys are then distributed at designated events where families are invited to holiday parties to receive toys for all their children. Additionally, the Soboba Gives Back! program provided 40 nonprofit organizations with toys to share at their own events. In all, nearly 6,400 toys, valued at \$20 each, were distributed to the community this holiday season.




staff at the US Vets Villages at March Air Base and San Bernardino, population almost 250.
